- > opposing any and all practices of labour and worker exploitation and the denial of workers' rights for the benefit of a pure profit rationale;
- > the promotion of constant and effective attention to potential situations of exploitation of workers by, inter alia, monitoring possible or potential commission of offences of illegal brokering and exploitation of labour;
- respecting labour law regulations, also with regard to the use of workers from third countries.

Raise awareness and train workers to perform their work safely and assume their responsibilities, through the following actions:

- > Define and maintain initiatives aimed at developing a culture of health, safety at work, environment and social responsibility, in accordance with international standards, through the involvement of all personnel;
- assign individual responsibilities and involve all levels of the organisation, ensuring that responsibilities and operating procedures are precisely defined, appropriately communicated and clearly understood;
- informing and, where necessary, training and instructing workers in compliance with the operating procedures aimed at protecting the safety and health of workers and protecting the environment, requiring strict compliance.
